## **Bios of our Green Theme Presenters**

Kelly Karll is Manager of Environment and Infrastructure programs and a certified professional engineer with the Southeast Michigan Council of Governments. She has over 26 years of experience in municipal engineering, regulatory programs, consulting and regional planning. She led the development of the Water Resources Plan for Southeast Michigan and is currently leading the region's water asset management and infrastructure coordination activities. She also leads regional efforts to integrate environmental priorities, including stormwater management, into various transportation planning activities. In 2017, she was Michigan Water Environment Association's Watershed Management Professional of the Year. She has managed millions in grants over the span of her career, including grants from federal and state agencies and local foundations. Kelly received her Bachelor's degree in Civil Engineering and her Master's in Environmental Engineering, both from Michigan State University.

Katie Grantham is an Environmental Planner with the Southeast Michigan Council of Governments (SEMCOG). Katie works in SEMCOG's Environment and Infrastructure group, primarily focusing on watershed planning and education, air quality and solid waste activities across the region. She helps lead the collaborative One Water Marketing campaign and an EPA green infrastructure grant program for local communities. Prior to joining SEMCOG, Katie worked as a graduate student, studying urban green space and agriculture in Detroit. Katie received her Bachelor's Degree in Environmental Biology from Michigan State University, and her Master's Degree in Environment and Sustainability from the University of Michigan. When Katie isn't working, you can find her kayaking and hiking all over Michigan.

## Environmental Commission Meeting Summary: 3/3/2021 (draft)

**Attending:** John Sarver, Ned Jackson, Rose Vadnais, Bill McConnell, and Tom Frazier. **Staff:** LeRoy Harvey, Stephen Gebes, Samantha Diehl, HOMTV **Guests:** Lori Welch, John Esser, Kendra Grasseschi, Anna Colby, Ben Holland, Elaine Putvin.

**Green Theme:** Lori Welch, Lansing Sustainability Manager, discussed the new Material Recycling Facility at 1159 S. Pennsylvania run by Emterra. This public-private partnership involves Lansing, East Lansing, and others in the region. This new facility will include state-of-the-art equipment. It is being constructed on an old industrial site. While it is being designed to sort single-stream recyclables, it may eventually include a drop-off site and an educational center. Welch also described CASP, the Capital Area Sustainability Partnership.



Sarver asked about the end markets of recyclables and Welch responded that most of Lansing's recyclables likely stays in North America. She feels that Emterra will be more likely to market locally than their current processor, Republic out of Detroit. Jackson asked about glass processing and potential use in concrete and potential collaboration with the Potter Park Zoo. Welch also suggested a tour of the facility and more conversations with them about future options. McConnell asked where Meridian's recyclables go. Harvey responded that there is not clarity from American Waste about how much is actually recycled vs. landfilled or burned. Welch mentioned that Granger is talking with Emterra and already sending some material to them for testing. **Additions to the Agenda:** Jackson suggested adding Environmental Stewardship Awards. McConnell moved to approve the Agenda and Jackson and Vadnais seconded. Approved unanimously.

**Minutes:** Vadnais moved to approve the minutes. Frazier seconded. Approved unanimously.

**Public Remarks:** Anna Colby introduced herself as a candidate for both the Environmental Commission and the Land Preservation Advisory Board. She has decade of public policy experience food assistance and food systems. She also loves the outdoors. (resume, cover letter, and application in March E.C. packet)

**Resolutions of Appreciation:** McConnell and Jackson read resolutions drafted by Harvey to recognize retiring Commissioners Susan Masten and Jim Kielbaso. A resolution of Appreciation for Dr. Susan Masten was offered and read by McConnell and supported by Sarver. Unanimously approved. A resolution of support for Dr. James Kielbaso was offered and read by Jackson and supported by McConnell. Sarver echoed appreciation for Kielbaso and Masten.

**Applicants for Public Service:** Harvey gave a brief overview of the three applications in the packet. Sarver invited Grasseschi and Colby to offer comments which they did. Ike Iyioke was not able to attend. McConnell expressed appreciation for the applicants' experience in policy and wetlands. Sarver mentioned sending a memo to Supervisor Ron Styka sharing our comments, recording of the meeting, and minutes.

**Citizen's Climate Commitment (CCC):** Sarver described the CCC which encourages people to consider electric vehicles and appliances when they need to be replaced. This will have positive impacts on the climate, particularly as the electric grid moves toward 100% renewables. McConnell suggested the Green Neighbors Network as a way to promote. Sarver mentioned having the information on the web, endorsement by the Energy Team, E.C., and Township Board, as well as word-of-mouth. Vadnais mentioned passing this on to the Board of Realtors. Sarver invited further comments. Jackson mentioned a concern that we are not recommending a specific product or contractor. He also asked about back-up power. Sarver responded that this is just a piece of a larger effort to educate people issues and opportunities. McConnell mentioned that we might frame this as part of our larger Climate Sustainability Plans. The CCC is relatively easy step for the public (We're just asking people to *consider* the options) and it builds upon the Township's internal efforts. This might include reference to MI Solar Stories and tools like energy audits that have been highlighted there.

**Environmental Stewardship Awards:** Jackson expressed sentiment that it has generated community pride and awareness. McConnell mentioned several brownfield projects that have demonstrated impressive public-private partnerships to clean up extensively contaminated sites. Harvey will share the history of the Awards and potential timeline.

**Green Infrastructure Grants:** Harvey has received drafts for proposal from Okemos High School and Radmoor Montessori. 1-page proposal are due on March 15. Holland has been working with the OHS Earth Club to envision and design a rain garden. Harvey will distribute drafts to Trustee Wisinski, Chair Sarver, and Holland for comments. Holland will also put in a plug for the Student E.C. vacancy. Jackson suggested a potential meeting with Earth Clubs in the future. The review committee will present recommendation to the EC in April. Sarver also mentioned a potential presentation to the EC and practice run for a presentation to the Board. Harvey mentioned Essers idea encouraging students to document their projects. Jackson will also explore potential tree planting connections in Haslett.

**Tree City Update:** Vadnais reports that there is progress stemming from a meeting between the tree team and representatives from Parks, DPW, and Planning. Derek Perry will look at the application and the Parks Board will also assist in clarifying the current policies. A future "Tree Board" may include reps from these departments and the E.C.

**Chair's Report:** Sarver mentioned interest in a Green Fair at the Marketplace later in the summer. This idea emerged at a Wednesday Green Dialogue. Both Luann Maisner from the Parks Department and Supervisor Wanda Bloomquist are interested.

**Staff Report:** Shared links to the Green Dialogue meeting and evolution of the Green Neighbors Network. He invited articles or ideas for the Green Gazette. He also share about future Green Themes, the Harris Nature Center Plant Sale, interest in a Community Garden location in or near Ottawa Hills and a potential recycling event. McConnell wondered if the new train extension and land preserve near Ottawa Hills might have space?

**Transportation Commission:** McConnell reports that the TC hasn't met since Jan 21.

**Planning Commission:** McConnell reports that the main issue at the last meeting was a public hearing on a zoning amendment requiring Township approval for special use permits for car dealership and planned unit developments with large amounts of impervious surfaces.

**Michigan Government Update:** Frazier reports that there is a softening of restrictions allowing gatherings of 25 people. This might affect in-person gatherings starting Mar 5. HB 4236 has been introduced lifting the 1% cap on distributed generation (allowing more solar connection to the grid).

**Land Preservation Advisory Board:** Harvey reposts that both Colby and Grasseschi have expressed interest in becoming involved with the LPAB.

**Green Team:** Meeting next week to discuss a recycling event and potential related green fair.

**Environmental Justice:** Vadnais shared a [link](#) to a fireside chat about equity related to water that the Michigan Environmental Commission is hosting. With water, there is a "ripple" effect on housing and a host of other issues.

**Energy Team:** Sarver mentioned the new solar array and discussions about the Citizen's Climate Commitment. Jackson asked about the carbon impact of the new solar array on the Service Center (and other solar systems). Sarver invited Harvey to share this section of the Absolute Solar's proposal.

**Environmental Justice:** C. Wisinski mentioned a recent opportunity to support improvements at Winslow Mobile Home Park. Vadnais mentioned a recent forum about the connection between the Black Lives Matter and the Env. Justice movement. A key point was encouraging people with privilege to work on larger systemic change.

**Brownfield Redevelopment Authority:** Jackson reports that there has not been a meeting.

**Adjournment:** Meeting adjourned at 8:40 pm.

2. **Environmental & Social Justice:** There are issues in Meridian Township and throughout the state that need to be addressed. I have many ideas, some of which I have already shared with Courtney and Rose. I am educating professionals on these topics. In April, I will be presenting at the Michigan Chapter National Association of Social Workers. My presentation is entitled: **"Be the Change"-Environmental Social Work Ethics in Practice.**
3. **Diversity, Equality, and Inclusion: Create change by actively addressing these with public policy and action.**
  - Implicit Bias training
  - Clear consistent interview and decision making process for choosing employees and commissioners.
  - Helping those with disadvantage feel safe to be seen and heard. For example, did you know that there are minorities that are interested in GNN but do not want to be more noticed by their neighbors due to active racism in our community? I hope to have an impact on changing this part of our environment.
  - Connect residents with resources. I have been actively involved in connecting clients with resources for 25 years. This includes food, shelter, safe living conditions, job skill training etc.
  - Find where the gaps exist in policy and change public policy to fill in the gaps.
4. **Green Neighbor Network Leadership Team:** The grassroots effort of this group can make a huge impact on addressing our climate crisis. As I often say, we need to help break things down into **simple action steps** with **simple dos and don'ts**. And help people care and get buy in by helping them understand how it impacts them.
5. **Environmental Education & Action:** Educating residents on helpful ways they can help sustain the environment. Educating with **social media outreach, educational brochures, and educational outreach, and signage.**  
**Everyone wants Clean Air and Water.** To that end, **let's educate residents** on the importance of...
  - Wetlands: Protecting the wetlands and 20 foot natural vegetation strip
  - Native Plants: My commitment is evident by planting 327 native plants. I am willing to help educate residents on it with photos. But I think Emma is already doing it.
  - Rain Gardens: Also have a rain garden, we can show photos and explain of the importance of them.
  - Water Conservation
  - Trees: Very important for clean water, air, and to manage energy. And per the fire chief, trees helped the fire on Van Atta to not spread further, despite the winds. (Rose has started work on this and I am willing to help).
  - Solar: (John has that covered.)
  - Recycling: (It seems like LeRoy and others have that covered.)
  - Energy saving means including transportation, home modifications etc.
  - Perhaps there could be some tax incentives to help encourage environmentally friendly practices.
6. **Green Grants:** But even more importantly, **getting environmental education part of the curriculum** (as Sarah Allen is already doing it in Okemos). Did you know that it is part of the wetland code to educate schools on the wetlands?
7. **Fun activities engaging environmental education for the schools and community.** If we get kids to care, we then also get the parents involved. I have many ideas but please see a couple of them below.
  - **Green Fair:** We discussed at Green Dialogue, where I shared my idea to have different environmental education topics and activities concurrently at several township parks.
  - **Big Year** (modeled after the movie): Kids and residents could compete finding birds throughout the township. It would help Audubon research and help us know the health of our ecosystem.
8. **Citizens Climate Agreement:** To add to John's idea for the agreement, I would add **planting native plants and trees**, which are easy action steps that people can choose to take.
9. **Environmental Communication Gaps between Commissions:** Protecting the Wetlands etc."
